THAT The Delegates and Board of Girl Scouts of Western Washington propose to amend the word 'girl' to the word 'youth' in the credentials and further to add a bullet stating "Feels that the Girl Scout experience and environment aligns with their gender identity."

MEMBERSHIP REQUIREMENTS

Membership as a Girl Scout is granted to any girl youth who:

- has made the Girl Scout Promise and accepted the Girl Scout Law;
- has paid annual, or other applicable membership dues;
- meets applicable membership standards.
- feels that the Girl Scout experience and environment aligns with their gender identity.

REASONS:

- 1. What is the issue the discussion topic or proposal is trying to address?
- 2. Are there other ways to address this issue?
- 3. How does this proposal improve Movement governance or policy? OR How does this discussion topic inform Movement strategy?
- 4. Does this agenda item have Movement-wide significance? Does it apply to all councils?
- 5. Is this agenda item time-sensitive? What happens if it is not addressed at NCS 58?

Members of Girl Scouts have shown that they may not view gender with the same binary lens as the language that is currently reflected in the Girl Scout membership credentials. To remain relevant there is a need to ensure that young people who resonate with the girl experience and yet do not feel comfortable with a 'girl' label can find a place for themselves within Girl Scouts, especially with the increasing number of youth who do not identify with the word girl.* Making these changes ensures that youth see Girl Scouts as a welcoming environment and helps individual councils with inclusive language when youth or parents inquire about membership.

This change would apply across the Movement but would not change the way many councils already welcome non-binary and gender-expansive youth into their council. With a consistent definition of Girl Scout, we can ensure that every youth who identifies with the girl experience is welcomed in every council to be a sister to every Girl Scout.

Inclusive language that reflects Girl Scout membership and upholds the Girl Scout core values and emphasizes respect for self and others. Inclusive language directly supports these principles by:

- Promoting respect and kindness toward all individuals
- Fostering a welcoming, safe and affirming environment for every member
- Ensuring members feel valued and more connected to the organization
- Motivates members to participate and lead
- Enhances retention, engagement, and the overall success of programming.

If this proposal is not addressed at NCS58 the wording in the membership credentials continues to alienate a segment of the population that could find community in Girl Scouts, and delays forward progress on ensuring that Girl Scouting remains relevant into the future.
